# **Additional Important Info**

When a call is placed to 911 the dispatcher will send the closest unit. MAL has reciprocal agreements with other Perry County BLS Companies. If MAL is unable to respond to your emergency and you or your family members are transported by another Perry County BLS company your subscription will be honored. Reimbursement will not be made by PSHLL for ALS services provided by covering ALS agencies.

f you or your family members would require emergency medical services outside of Perry County your subscription will not be honored.

Emergency Medical Services are broken into two evels of care. Basic Life Support (BLS) and Advanced Life Support (ALS).

- BLS is an ambulance staffed by an EMT and a driver. They respond to critical and non critical calls. The BLS company will transport patients to the hospital. MAL is a BLS company.
- ALS is a unit that is staffed by a paramedic. They respond to higher acuity calls. These units provide treatments for cardiac events, strokes and multi system trauma. They provide medications, start IV's and do cardiac monitoring. The ALS providers will work with BLS companies to treat patients while being transported to the hospital. PSHLL is an ALS provider.

Subscriptions will NOT cover non-emergency or routine transports.

MAL reserves the right to refuse or revoke any subscription.

ndividuals must have health insurance or Medicare to be eligible for membership. The subscription program s not applicable for Medical Assistance recipients.

f a unit is called and you **refuse to <u>NOT</u> be transported**, you will receive a bill **NOT** covered under membership.

A permanent resident over the age of 18 **DOES NOT qualify as a guest**. A single or family membership is required.

# **2025 Subscription Options**

#### SINGLE:

Covers any single, widowed or divorced person 18 years of age and older for up to three calls per year ALS COVERAGE INCLUDED

#### **FAMILY:**

Entitles a husband, wife and any children under 18 years of age to this coverage. Full-time college students up to age 23 are covered in a family subscription. Each member is covered for three calls per year. Any other person living in the household needs their own membership. ALS COVERAGE INCLUDED

#### **GUEST:**

This covers any guest only visiting your home who is <u>NOT a resident</u> of the Millerstown service area. This person will not be billed for excess their insurance company does not cover for the ambulance services provided. ALS is also provided with this subscription.

COVERAGE PERIOD IS JANUARY 1, 2025 TO DECEMBER 31, 2025. PAYMENT MUST BE RECEIVED 30 DAYS PRIOR TO SERVICE.

# **Billing**

In the event that you receive direct payment from your insurance company for ANY Emergency Medical Service, <u>You MUST</u> forward the check to our billing company or be subject to collection.

If payment is not received, collection actions will be taken. Even if you are a member, collection action can be different ways, one of which can be wage attachment.
